NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:-

1. TRUST FUND

The AUTHOR has transferred, delivered and assigned the said sum of Rs.10,001/- (Rupees Ten thousand and one only) to the Trust. The Trust will function from its Registered Office at # A-2, Gagan Tara, No.6, Dinnur Main Road, R T Nagar Post, Bangalore-560032 and/or at such other places as may be decided from time to time by the board of Trustees. The Trust shall open branches/administrative offices/liaison offices at such places as the board of Trustees may decide from time to time.

THE TRUST can also achieve its objects mentioned below and function through entities/bodies established in various names.

3. OBJECTS OF THE TRUST:

1. EDUCATION:

- To promote the cause of education, by giving donations or other assistance to schools, colleges, libraries, reading rooms, laboratories and other centers of learning & research.

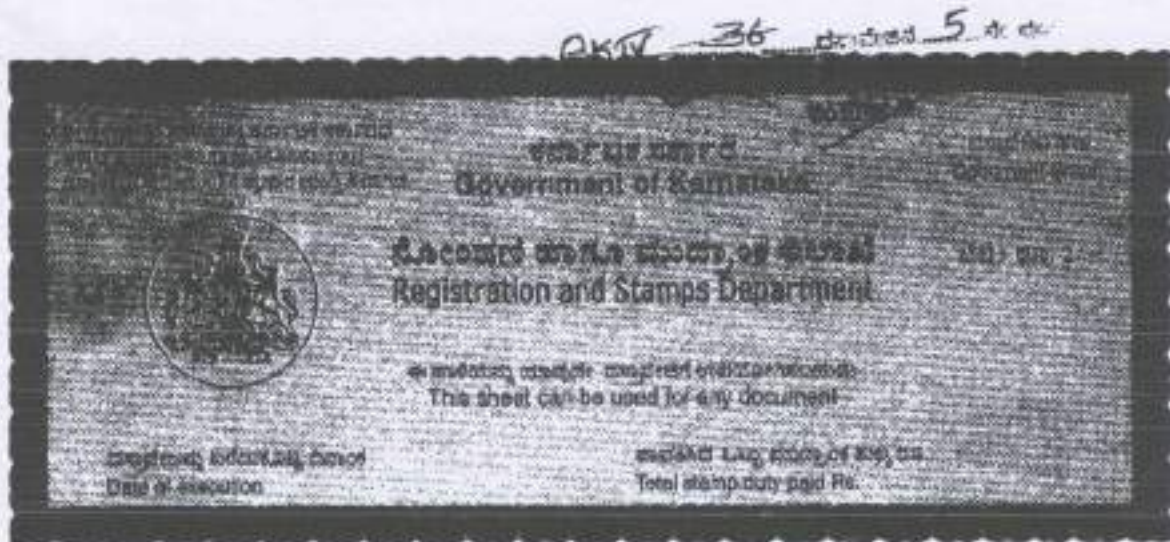

II. MEDICAL RELIEF:-

- To donate/help institutions, hospitals for mentally/IQ challenged in providing treatment, shelter, food, clothing or other help.
- Granting of subscriptions / donations to Hospitals, Charitable Dispensaries, Convalescent Homes, Asylums, Orphanages and other public institutions for administering medical relief to the needy wholly on philanthropic causes
- To offer and provide help to health camps for- that is to say dental, eye, ear, nose and throat, tuberculosis, mental, hygiene, leprosy, pre-natal and other such similar camps and to pay for the medical, surgical and hospital care, milk food, fruits, medicines etc., and to give relief to the poor and the under privileged.
- To help in promoting preservation of natural environment and Indian heritage by helping financially organizations actively engaged in such activities.
- To help monetarily for Orphanages/Old age homes, Homes for physically challenged / disabled men, women and children. To carry out all other humanitarian acts and projects calculated to benefit the public in matters of education, health and social welfare irrespective of caste, creed or sex.

III. RELIEF TO THE POOR

- To support the needy children with education, support system such as conducting free coaching classes, providing books and other study equipment to the needy schools.
- To provide complete school education as well as help find and fund the admission to colleges to underprivileged children belonging any caste creed or community.
- To provide financial assistance to deserving meritorious students and economically weaker sections for professional studies like engineering/accounts/medical.

The Trust shall however not carry on any trade, or commercial activity which is not incidental or ancillary to achieve the objects of the Trust.

4. TRUSTEES

- The number of Trustees shall be Three (3) at present and shall not exceed Twelve (12) at any stage and the minimum number of trustees shall be two (2) at any stage.
- In the event that the number of trustees falls below three (3) in numbers, the remaining trustee(s) may appoint a person as trustee, provided that the person so appointed has attained the age of twenty (20) years.

c) The Author of the Trust hereby appoints the following persons as Trustees for life time:

- 1) Sri R.SRINIVASAN
- 2) Sr. R. BALASUBRAMANIAN.
- 3) Smt. INDIRA SRINIVASAN

d) **CHAIRMAN AND MANAGING TRUSTEE OF THE TRUST:**

Sri R.SRINIVASAN shall be the Chairman of the Trust for life unless he resigns earlier and shall also be the Managing Trustee of the Trust.

e) The Board of Trustees shall have the power to nominate or co-opt other TRUSTEE/S as they may decide from time to time.

5. **TERM OF OFFICE OF TRUSTEES**

Each of the present TRUSTEES shall hold office for life or until he/she resigns or is disabled by sickness or otherwise.

- a) The other TRUSTEES to be nominated other than the Three persons mentioned as founder trustees in this deed shall hold office for a period of two (2) years from the date of his/her nomination or for such period as the present TRUSTEES may decide upon or until he/she resigns or becomes incapable on continuing in office due to sickness, disability or otherwise.
- b) On the demise of either of the Trustees or if for any other reason, a trustee is discharged or removed from office, the remaining trustees may by resolution appoint a TRUSTEE provided that the person so appointed has attained the age of twenty (20) years. The person so appointed as TRUSTEE shall be deemed to take office on the date of demise of the previous trustee or from the date that the previous TRUSTEE was discharged or removed from office, as the case may be.
- c) Provided that if for any reason a TRUSTEE wishes to vacate office, he/she may do so by intimating his intention to resign, in writing, to all other TRUSTEES and the Managing Trustee appointed. The resigning TRUSTEE will have the right to appoint a TRUSTEE in his/her stead, by failure to appoint a Trustee simultaneously with the resignation. The person so appointed shall have attained the age of twenty five (20) years. Both the resignation and appointment of the succeeding Trustee shall take effect two months from the date of receipt of communication by the Managing Trustee.

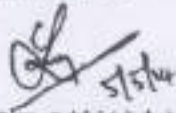

- d) The Managing Trustee of this trust shall be Shri. R. SREINIVASAN
- e) Any Trustee may be removed from office by resolution of the majority of Trustees:
- Who becomes bankrupt or a lunatic or;
 - Abseints himself/herself without leave of absence from five consecutive meetings of the Board of Trustees, shall automatically cease to be a TRUSTEE of this TRUST.

6. VACANCIES

Vacancies occurring in the office of the TRUSTEES, including that of the Managing Trustee shall be filled by the remaining TRUSTEES, fixing a specified term, if they so decide, subject to the incumbent being qualified to be co-opted as a Trustee.

7. VACANCY NOT TO INVALIDATE

No vacancy in the Board of TRUSTEES shall invalidate any act or decision of the other TRUSTEES constituting the Board of Trustees.

8. ADMINISTRATION OF THE TRUST

- All power of administration, control and authority in respect of the Trust and its funds/properties shall vest in the Board of Trustees for the benefit of and for the achievements of the objectives and purposes of the Trust.
- The Board of Trustees shall be deemed to be the Governing Council established and maintained by it, of educational institutions to which the affairs of the said educational institutions will be entrusted.

9. APPLICATION OF TRUST PROPERTY & FUND MANAGEMENT

- The funds and the income of the Trust shall be solely utilized for the achievement of its objectives and no portion of it shall be utilized for payment to the Trustees by way of profit, interest, dividend etc. The TRUSTEES shall not apply, divert or transfer any of the properties, assets or funds of the Trust for any purpose or objects other than those set out in this Deed. (However, if any TRUSTEES personally render any service of nature provided for in this Trust Deed, he/she shall be paid expenses if approved by majority of The TRUSTEES on the basis of actual expenses incurred.)
- The Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto, but such expenses to be restricted to 10% of the yearly income which will be mainly from the interest accrued on deposits.
- The Trustee shall invest the Trust fund in Government securities, savings certificates, fixed deposits or in any other of investment authorized under provisions of INDIAN TRUST ACT AND INDIAN INCOME TAX ACT, 1961 as they shall deem expedient.

10. POWER OF THE BOARD OF TRUSTEES

- To decide all matters relating to the scope, objects and purposes of the Trust.
- To decide all matters touching relations and cooperation with other institutions, government bodies, Universities or local authorities.

- c) To determine, sanction and allot recurring and non-recurring expenditure of the Trust and/or institutions created under the Trust and to direct and approve capital and other expenditure. The Board of Trustees shall form such rules for the conduct of their and of the proceedings of their meetings as they may consider proper and the same may from time to time be amended, altered or added to, as the case may be, by them.
- d) The board of TRUSTEES may, if they consider it appropriate, be advised and assisted by a Governing body in respect of the governance and administration of any institutions, establishments and the like created under the Trust and shall consist of such members and shall have powers and functions as may be prescribed by regulations framed in that behalf from time to time by the Board of Trustees. The TRUSTEES shall have powers to constitute Governing Bodies for the day to day administration of the institutions created under this trust and delegate to such Governing Bodies all or any of their power and functions under this Deed, and to make regulations from time determining the powers and functions of the Governing Body created for the said purposes and the day to day administration of the institutions and establishments created under the Trust.
- e) The TRUSTEES shall ordinarily meet once in a month after clear three days, notice, issued by the Managing Trustee or by such other person/s duly authorized by the Managing Trustee to all the other TRUSTEES in this behalf.
- f) The TRUSTEES shall have power from time to time appoint such staff, assistance and/or employees on such remuneration and terms as they may deem fit for the administration of the Trust.
- g) All powers vested in and exercised by the Board of Trustees shall be capable of being performed or exercised by a majority among the members of the Board of Trustees from time to time and any action or decision of such majority shall be valid and effective as if done by the Board of Trustees.
- h) The Board of Trustees shall have power from time to time constitute a committee consisting of one or more persons for such period as the Board of Trustees may decide upon, for obtaining aid and advice, in carrying out the objects of the Trust.
- i) The TRUSTEES shall have power to negotiate, conclude and effectuate such agreements with state or Union Governments of foreign, state, local bodies, association or persons, authorities, firms, companies, individuals or other entities, in India or abroad, for acquiring land and building to be used for the purpose mentioned here in as well as for the purpose of obtaining financial or technical aid or assistance on such terms and conditions and in such form as they deem appropriate for the furtherance of the purposes and objects of the Trust.
- j) To maintain aid, assist, support, donate or otherwise contribute funds to societies/institutions/trusts and without discrimination of any kind or nature whatsoever and other funds recognized for the purpose of allowing deduction under section 80G of Income tax Act, 1961.
- k) The Trustees are bound by all the liabilities cast upon them under the Indian Trust Act of 1882 except to the extent of the powers specifically conferred under these presents.
- l) The Managing Trustee or any Trustee authorized by the Trustees shall have powers to receive and issue receipts for any monies paid to or received by the Trust in the day to day administration and management of the Trust.

- m) The Trustees may at any time invite and receive voluntary contribution from any person or persons whomsoever by donation legacy, gift, annual or monthly subscription for the benefit of the charity thereby constituted. All conditions attached to such voluntary contributions offered shall be only in conformity with the objects of the Trust as specified above.
- n) The Trustees shall as far and as early possible, apply such contributions in accordance with the objects of the Trust constituted.
- o) Proper accounts showing all receipts and disbursements made on accounts of the Trust and charities hereby constituted shall be kept by the Trustee and shall be duly audited with all necessary vouchers once at least in every year by a Chartered Accountant whom the Trustees shall appoint.
- p) The Trustees shall respectively be chargeable only for such moneys stocks, funds, goods, shares and shall be accountable and answerable only for their own acts, receipt, neglects and defaults and answerable only for those of any bankers, brokers, auctioneer, or other persons with whom or into whose hands the Trust moneys or securities may be deposited or for insufficiency or discrepancy in value for any investment or for any other loss unless the same shall happen through their wilful default respectively.
- q) The Trustees may reimburse themselves or pay and discharge out of the Trust funds expenses incurred in or about the execution of the Trust and powers of these presents or any of them, subject to ratification and approval by the other Trustees.
- r) The Trustees may from time to time appoint a secretary/Legal Adviser/Accountant, Clerk and other officials and employees as the Trustees may deem expedient and fix and pay their remuneration out of the Trust fund or the income thereof and also, if though fit, shall have power to terminate their services.
- s) The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of this charity be considered as capital or income and whether out of income or capital any expenses or outgoings shall or ought to be paid or borne and only every such determination shall be binding and conclusive, provided that nothing herein contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust fund for any purpose not authorized by these presents.
- t) The Trustees shall have the power to appoint managing or other committees to entrust or charge with the management and administration of the educational institutions established by it in its name or in any name as may be decided by the Board of Trustees.

11. DUTIES OF THE TRUSTEES

- a) The Trustees shall take all the necessary steps to get the aforesaid Trust registered under section 12A of the Income tax Act, 1961 and the rules framed there under and also seek and obtain recognition under section 80G of the Income tax Act, 1961.
- b) The funds of the Trust shall be invested in any of the modes specified under the provisions of section 13(1)(d) read with section 11(5) of the Income tax Act, 1961 and as amended from time to time and shall include investments:

- i. In fixed or any other kind of deposit with any Nationalized/Scheduled Bank.
- ii. Investments or Deposit in any public sector company.
- iii. In immovable Property
- iv. Any other form or mode of investment or deposit as may be prescribed u/s 11(5) of The Indian Income Tax Act, 1961 or under any amendments there on from time to time.

c) The Trustees shall from time to time apply the whole or any part, at their discretion, of the net income of the Trust including donations and other capital sums received by them for all or any of the following purposes that is to say:

- i. Proper maintenance and running of "Sri. K. Srinivas Iyer Charitable Trust."
- ii. To undertake activities connected with help and education to the deserving people.
- iii. To render financial or other assistance to the needy and deserving persons for education, marriage and any other causes deemed fit
- iv. To undertake services projects etc., especially for the welfare of women, children and the aged
- v. To contribute funds to institutions having similar objects and which are recognized for the purpose of and under section 80G of the Income tax Act, 1961.
- vi. To extend financial assistance to needy and deserving students and aged.
- vii. To promote such other object not contrary to the spirit of the Trust as the Trustees may add to the above mentioned object having regard to the particular needs of the time, provided that the application of the estates shall be done and also provided that this clause does not envisage expansion of the objects of the Trust or inclusion of any other object or objects which are inconsistent with or repugnant to the provisions of section 80 G of the Income tax Act, 1961 or any other relevant provisions of the Income tax Act.

12. MANAGEMENT OF THE TRUST

The management and control of the property and affairs of the Trust aforesaid shall be vested in the Board of Trustees with full powers and authority to hold any land or hereditament acquired or any funds of any other properties or investments at any time, subject to the Trust formed by these presents. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and charities as they shall think fit and to alter or vary the same from time to time and to make new rules and regulations provided such rules and regulations shall not be inconsistent with the terms and intents of these presents provided however that the Trustees shall not make any amendments to the Trust Deed without obtaining the prior consent from the Commissioner of Income-tax as elsewhere provided.

13. MEETINGS OF THE TRUSTEES

The Trustees shall meet as often as possible for purpose of efficient management of the Trust to take stock of its income and expenditure and for disposing of all such other matters as arise in such meeting.

- a) At all meetings of the Board of Trustees, a minimum of two (2) members shall form the quorum.
- b) At all meetings of the Trustees if the Chairman is absent, any of the trustees as may be decided at the meeting shall be the Chairman. All decisions at the meeting shall be by majority vote and the Chairman present shall have a casting voting in case of an equal division of vote.
- c) All proceedings of the meetings of the Trustees shall be recorded in a Minutes book kept for the purpose and shall be signed by all Trustees present at the meeting. An Attendance register for all

meetings of the Board of Trustees shall also be kept to record the presence of the Trustees for such meetings.

- d) There shall be maintained all accounts of the Trust regularly. The accounts shall be duly audited by a Chartered Accountant. The accounts of the Trust and all other bodies/ institutions established under it shall be closed on the 31st of March every year.

14. DISSOLUTION OR WINDING UP OF THE TRUST

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under, no circumstances be distributed among the Trustees, members of the Managing Committee/Members of the Governing body, but the same shall be transferred to another Trust, Society, Association or Institution whose objects are similar to those of this Trust and which enjoys recognition under section 80G of the Income tax Act, 1961 as amended from time to time.

15. IRREVOCABILITY

The Trust formed shall be irrevocable.

16. The Benefit of the Trust shall be open to all irrespective of caste, creed or religion.

17. The funds and the Income of the Trust shall be solely utilized for the achievement of its objects and no portion of it shall be utilized for payment to the Trustees/Members by way of profit, interest, dividends etc. (However, if any TRUSTEES personally render any service of nature provided for in this Trust Deed, he/she shall be paid expenses if approved by majority of the TRUSTEES on the basis of actual expenses incurred.)

18. CONSTITUTION OF SUB-COMMITTEES

- a) The Board of Trustees shall have the powers to constitute one or more sub-committees among the trustees for specified purposes and/or for specified terms.
- b) Any member of the sub-committee who does not attend three (3) consecutive meetings of the Sub-Committee without being granted leave of absence shall cease to be a member of the Sub-Committee.

The quorum for the meeting of the Sub-Committee shall be two (2) members of the Sub-Committee personally present.

19. BANK OPERATION

An account shall be opened in a scheduled Bank in the name of the Trust or in the name of the Institution/body established by the Trust. The said accounts shall be operated by Shri.R.Srinivasan and Sri. R.Balaasubramanian who are authorized to operate the said account/s jointly. A Sub-Committee may be formed to open and maintain the accounts of the Trust for all the moneys received and spent along with duly signed vouchers and receipts. The sub-committee is authorized to meet all the expenditure under the direction and with the knowledge of the Board of Trustees. The Bank accounts of the Trust which are authorized to be operated by the sub-committee i.e the president, the secretary or the Treasurer of the sub-Committee duly authorized by the Board of Trustees wherever found necessary.

20. ACCOUNTS

- a) The accounts of the Trust shall be maintained regularly. The accounts shall be duly audited by a Chartered Accountant appointed by the Board of Trustees or the sub Committee as the case may be and shall be closed on the 31st March every year.
- b) The account books, registers, etc., of the Trust shall be made available for inspection to the Trustees as and when find it necessary to do so.

22. In respect of rights and powers of Trustees herein provisions made under Chapter IV of the Indian Trust Act, 1882 shall apply.

23. In respect of all other matters for which no provisions or insufficient provisions is made in this Deed, the provisions of the Indian Trusts Act, 1982 shall apply.

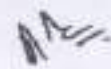

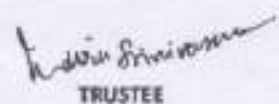
